## Student Training Agreement

**Bick's Driving School of Southwest Ohio ("Bick's")** agrees to provide the individual named above ("**Student**") with 24 hours of Classroom Training (if applicable) and 8 Hours of Behind-the-Wheel Training, based on the Ohio Teen Driver Training Curriculum.

**Classroom Training:** The Student may begin their 24 Hour In-Person or Online Classroom instruction at 15 years and 5 months of age. A temporary driving permit is not required for classroom training. If the Student is unable to attend an in-person classroom training (6 Sessions, 4 Hours Each), or is late by more than 15 minutes, attendance in a future class is required for each missed session. The Student must attain a final classroom score equal to or greater than 75% on the final exam. Retests must be scheduled for any exam grade of 74% or lower.

**Behind-the-Wheel Training:** Bick's furnishes a licensed instructor and a motor vehicle for 8 Hours of Behind-the-Wheel Training. The Student may schedule 4 Private Lessons (2 Hours Each) once this contract is signed, all Classroom Training is completed, front photo of Valid Ohio Temporary ID is provided, and Tuition is Paid in Full.

**The State of Ohio requires student training to be completed within 6 months of the initial training session:** \_\_\_\_\_. After expiration of this agreement, a reinstatement fee may be charged before any further services are provided.

**Behind-the-Wheel Cancellations must be made at least 24 hours prior to the scheduled appointment.** If the Student cancels on less than 24 hours prior notice, fails to appear for any reason, or is unprepared to take a Behind the Wheel lesson, a \$50 fee is assessed and must be paid before rescheduling.

**Refund Policy:** No refunds.

**Certificate of Completion:** Bick's issues a Certificate of Completion when the Student completes 24 Hours of Classroom and 8 Hours of Behind the Wheel Training. On weekdays before 4:00pm, the Certificate is provided directly to the Student; otherwise, the Certificate is emailed the following business day to the address on file.

**Prior to BMV testing,** the State of Ohio requires that a parent or legal guardian must supervise a MINIMUM of 50 Hours with their Student Behind-the-Wheel, and that the Student must have their temporary license for a MINIMUM of 6 months. Bick's offers additional in-car training for \$95/hour. The Student may use Bick's vehicle to take a driving exam at a Hamilton County Exam Center for an additional \$210. Bick's does not guarantee issuance of a driver's license to the Student.
